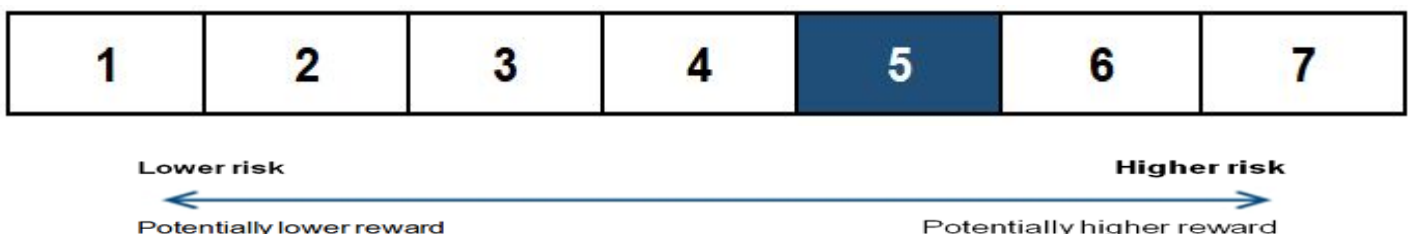

## What is this product?

<b>Type</b>	AVI Family Holding Companies Fund Class C (GBP) is a sub-fund of AVI Partners Capital Fund plc, an umbrella-type open-ended investment company regulated by the Central Bank of Ireland.
<b>Objectives</b>	The investment objective of the Fund is to achieve long-term capital appreciation in excess of the MSCI All Country World (ex U.S.) Index through the active management of a focussed portfolio of listed equity investments in family-backed holding companies. In seeking to achieve the Fund’s objective, the Investment Manager intends to invest in equities, fixed income, and other types of securities of companies which are “family-backed” that are trading at what the Investment Manager believes to be a discount to their net asset value. “Family-backed” refers to companies over which a family exerts influence.
<b>Gearing</b>	The Fund does not intend to borrow or incur leverage for investment purposes.
<b>Intended retail investor</b>	Due to the nature of the investment strategy, this fund may not be appropriate for investors who plan to withdraw their money within 5 years.

## What are the risks and what could I get in return?

### Risk Indicator



The summary risk indicator is a guide to the level of risk of this product compared to other products. It shows how likely it is that the product will lose money because of movements in the markets.

The manufacturer has classified this product as 5 out of 7, which is a low-medium risk class. This rates the potential losses from future

performance at a medium level.

**Be aware of currency risk.** If you are a non-UK investor, you will receive payments in a different currency, so the final returns you will get depend on the exchange rate between the two currencies. This risk is not considered in the indicator shown above. This product does not include any protection from future market performance so you could lose some or all of your investment.

### Investment performance information

As stated in the objectives, the Investment Manager of the fund is seeking to generate capital growth in excess of the MSCI All Country World (ex U.S.), through the active management of a focused portfolio in family-backed holding companies.

The Investment Manager of AVI Family Holding Companies Fund observed over the last 5 years that this fund denominated in GBP has a volatility of 18.20% and a return of 5.18 % per year. Therefore, as an investor, you should be aware that your expected return will likely range between -24.76% and 35.11% with a 95% confidence. The above estimates are based on share price total return with dividends reinvested.

However, what you get will vary depending on how the Fund's underlying investments perform, how the overall market performs and how long you keep the investment and your loss could be larger than -24.76% in extreme market circumstances.

## What happens if AVI Family Holding Companies is unable to repay?

The Fund is an open-ended sub-fund of AVI Partners Capital Fund plc, an umbrella investment company with variable capital and with segregated liability between sub-funds. The Fund is subject to monthly dealing therefore investors will be able to close their investments on each month-end date subject to sufficient liquidity in the portfolio. As a shareholder of AVI Family Holding Companies Fund you would not be able to make a claim to the Financial Services Compensation Scheme (or equivalent overseas authorities in the case of non-UK shareholders) in the event that the company is not able to pay out.

## What are the costs?

The Reduction in Yield (RIY) shows what impact the total costs you pay will have on the investment return you might get. The total costs take into account one-off, ongoing and incidental costs.

The amounts shown here are the cumulative costs of the product itself, for three different holding periods. They include potential early exit penalties. The figures assume you invest £1,000. The figures are estimates and may change in the future.

### Composition of costs

Other ongoing costs of 2.40 % includes: 1.77 % ongoing charges (per latest annual report) and 0.63 % ongoing costs applied at the

underlying portfolio. Costs applied at the underlying portfolio consist of management fees, performance fees, carried interest, and gearing charges incurred by the closed-end funds into which the Fund invests. These costs are not suffered directly by the Fund through its Profit & Loss account.

Total fees paid to Asset Value Investors Limited (the Investment Manager) amount to 0.70 %. This charge is included within the ongoing charges figure quoted above.
