What is this product?				
Туре	AVI Japan Fund Class E (Founder) – JPY is a sub-fund of AVI Partners Capital Fund plc, an umbrella-type open-ended investment company regulated by the Central Bank of Ireland.			
Objectives	The investment objective of the Fund is to achieve long-term capital appreciation. The Fund will aim to exceed the returns of the MSCI Japan Small Cap Index through the active management of a focussed portfolio of equity investments listed or quoted in Japan. As is further set out in appendix I of the Prospectus titled "Risk factors", there is no guarantee that the Fund will achieve its investment objective. In seeking to achieve the Fund's objective, the Investment Manager intends to invest in a diversified portfolio of equities listed or quoted in Japan which are considered by the Investment Manager to be undervalued and where cash, listed securities and/or realisable assets make up a significant proportion of the market capitalisation. The Investment Manager will seek to unlock this value through proactive engagement with management and taking advantage of the increased focus on corporate governance and returns to shareholders in Japan. The Company has not set any limits on industry or sector weightings or stock within the portfolio. It is not expected that a single holding (including any derivative instrument) will represent more than 10% of the Fund's gross assets at the time of investment. However, the Fund will have discretion to invest up to 15% of its gross assets, at the time of investment, in a single holding if a suitable opportunity arises.			
Gearing	The Fund does not intend to borrow or incur leverage for investment purposes.			
Intended retail investor	Due to the nature of the investment strategy, this fund may not be appropriate for investors who plan to withdraw their money within 4 years.

The Fund is an open-ended sub-fund of AVI Partners Capital Fund plc, an umbrella investment company with variable capital and with segregated liability between sub-funds. The Fund is subject to monthly dealing therefore investors will be able to close their investments on each month-end date subject to sufficient liquidity in the portfolio. As a shareholder of AVI Japan Fund you would not be able to make a claim to the Financial Services Compensation Scheme (or equivalent overseas authorities in the case of non-UK shareholders) in the event that the company is not able to pay out.
