Manager commentary

Uranium proved to be our greatest contributor as the metal's spot price, being the current price in the marketplace at which it can be bought or sold, crept up steadily. Several commentators have highlighted the severe shortfall in supply which is developing. This has been exacerbated by energy security concerns given Russia and Kazakhstan's roles in the supply chain. Turmoil in Niger is disrupting supplies of Uranium to the French power industry. The decision to extend the lives of many power stations in an effort to achieve net zero is leading to demand being much greater than expected in the short term. Longer term demand will be driven by the build out of the nuclear industry in the Middle East and Asia.

Shares in Georgia Capital have continued their steady appreciation yet still trade at a discount in excess of 56%. The country stands at the traditional economic sweet spot where wealth has just reached the point where the population can afford to visit pharmacies, get their cars serviced and insured and pay to get their children educated. In the short term the local economy has been boosted by the arrival of much of Russia's IT Industry who prefer Tbilisi to the risk of being called up at home.

We have benefited from a bull market (the condition of a financial market in which prices are rising or are expected to rise) in smaller and medium sized Indian companies. Whilst we are positive about the outlook for Indian equities, we believe that local investors are jumping on the bandwagon and a bubble has started to form. Disappointments include Baker Steel Resources, Phoenix Spree Deutschland and Macau Property Opportunities.

The only completely new position was Ecofin US Renewables Infrastructure, following damage inflicted by a tornado on their wind farm in South Texas. We felt the shares fell to a level not justified by the situation.

Looking forward, the outlook is getting brighter. Expectations of further interest rate rises have petered out and investors will now anticipate their eventual decline. Given that backdrop investors will be attracted back. Trust share prices are languishing at levels that offer attractive yields.



Infrastructure


