What is this product?

This product has no specific maturity date. In certain circumstances, as described in the Fund prospectus, the Sub-Fund may be unilaterally terminated following written notice to unitholders subject to compliance with the Fund prospectus and applicable regulation.

Objectives

The investment objective of the Fund is to generate long-term returns. There can be no assurance that the Fund will achieve its investment objective.

The Sub-Investment Manager shall seek to achieve the investment objective by investing globally in a portfolio of companies whose share prices, in the opinion of the Sub-Investment Manager, stand at a significant discount to the Sub-Investment Manager's estimated underlying net asset value of those companies.

The Fund is actively managed meaning the Sub-Investment Manager uses their expertise to select investments to achieve the Fund's objectives.

The Sub-Investment Manager's investment philosophy is based on three key areas: seeking durable businesses that are growing in value; companies currently trading at discounted valuations to their share price; and an active engagement approach with company management to unlock and grow value for shareholders. The Sub-Investment Manager's process seeks to build a portfolio comprising circa 35 – 45 securities. The invested companies may represent a variety of industries and sectors, although there is no guarantee that this will be the case and the portfolio may contain a lesser or greater number of holdings at any time.

The Fund does not target any specific industry, sector, or geographic area, but will look to identify companies trading at a discount to their current net asset value, on a global basis.

The Fund will seek to achieve its objective by investing predominantly in equity and equity related securities. Where considered appropriate, the Fund may utilise financial derivative techniques and instruments for efficient portfolio management and/or to protect against foreign exchange risks.

The Fund is actively managed with reference to the MSCI All Country World Index Net Total Return for performance comparison purposes as well as for the purposes of calculating performance fees.

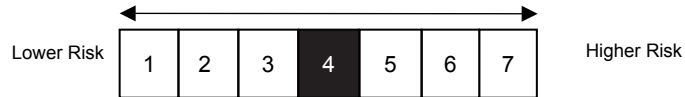

Intended Retail Investor

AVI Global Special Situations Fund is appropriate for Retail Investors, Basic, Informed and Advanced. The Fund is appropriate for investors who are seeking long-term returns. The fund may not be appropriate for investors that plan to withdraw their money within 5 years. Investors should be aware that 100% of their capital is at risk and investment is not appropriate for investors who seek a capital guarantee or can bear no capital loss including minor losses. The fund is not designed to preserve or limit capital loss.

What are the risks and what could I get in return?

Risk Indicator



The risk indicator assumes that you keep the product for 5 years. The actual risk can vary significantly if you cash in at an early stage and you may get back less. The summary risk indicator is a guide to the level of risk of this product compared to other products. It shows how likely it is that the product will lose money because of movements in the markets or because we are not able to pay you.

We have classified this product as 4 out of 7, which is a medium risk class.

This rates the potential losses from future performance at a medium level, and poor market conditions could impact the capacity of the PRIIPs manufacturer to pay you. Due to effects of unusual market conditions, other risks could be triggered, such as: Trading Risks, Portfolio Volatility, Market Risk, Market Disruptions, Operational Risk and Sustainability Risks.

Performance Scenarios

How long should I hold it and can I take money out early?

Recommended holding period: 5 years
