What is this product?

This product has no specific maturity date. In certain circumstances, as described in the Fund prospectus, the Sub-Fund may be unilaterally terminated following written notice to unitholders subject to compliance with the Fund prospectus and applicable regulation.

Objectives

The investment objective of the Fund is to generate long-term returns. There can be no assurance that the Fund will achieve its investment objective.

The Sub-Investment Manager shall seek to achieve the investment objective by investing in a focused portfolio of, what in the opinion of the Sub-Investment Manager are, over-capitalised Japanese equities, whilst engaging with companies to release value to shareholders e.g., the Sub-Investment Manager may seek to persuade the company to increase dividend payments, or to initiate share buybacks, or to make improvements in its operations. Over-capitalisation refers to a situation where the value of a company's capital is worth more than its total assets.

The Fund is actively managed meaning the Sub-Investment Manager uses their expertise to select investments to achieve the Fund's objectives.

The Sub-Investment Manager looks to invest in companies with high potential capital growth, and to engage with the companies, to release value to shareholders e.g., by way of example, increased merger and acquisitions activity, share buyback programmes or board change.

Companies shall be considered for inclusion in the portfolio if the Sub-Investment Manager believes that they are undervalued and where cash, listed securities, and/or realisable assets make up a significant proportion of their market capitalisation.

The Fund will seek to achieve its objective by investing predominantly in equity and equity related securities. Where considered appropriate, the Fund may utilise financial derivative techniques and instruments for efficient portfolio management and/or to protect against foreign exchange risks.

The Fund is actively managed with reference to the MSCI Japan Small Cap Index Net Total Return Index for performance comparison purposes as well as for the purposes of calculating performance fees.

Intended Retail Investor

AVI Japanese Special Situations Fund is appropriate for Retail Investors, Basic, Informed and Advanced. The Fund is appropriate for Investors who are seeking long-term returns. The fund may not be appropriate for Investors that plans to withdraw their money within 5 years. The investor should be aware that 100% of their capital is at risk and is not appropriate for investors who seek a Capital Guarantee or can bear no capital loss including minor losses. The fund is not designed to preserve or limit capital loss.

What are the risks and what could I get in return?

Risk Indicator



The risk indicator assumes that you keep the product for 5 years.

The actual risk can vary significantly if you cash in at an early stage and you may get back less.

The summary risk indicator is a guide to the level of risk of this product compared to other products. It shows how likely it is that the product will lose money because of movements in the markets or because we are not able to pay you.

We have classified this product as 4 out of 7, which is a medium risk class. This rates the potential losses from future performance at a medium level, and poor market conditions could impact the capacity to pay you.

Due to effects of unusual market conditions, other risks could be triggered, such as: Equity Risk, Trading Risks, Portfolio Volatility, Market Risk and Change in Market Conditions, Concentration Risk, Counterparty Risk and Lack of control and reliance on the Sub-Investment Manager.

Performance Scenarios

Recommended holding period: 5 years
